- A. The Academy started 2022 Alpha on January 10, 2022. We started with 36 cadets. We finished the class with 29, with 25 passing the state exam on the first attempt. Graduation was held on July 7, 2022.
- B. The Academy started 2022 Bravo class on April 11, 2022. We had 24 cadets start the class and 22 graduated.
- C. The Academy started 2022 Charlie class on July 11, 2022. We started with 36 cadets and as of today we have 34 cadets.
- D. The Academy started 2022 Delta class on October 10, 2022. We started with 26 cadets and as of today we have 21 cadets.
- E. The Academy started 2022 Echo class (Part-Time) on March 28, 2022. We started with 11 cadets and as of today we still remain with 11 cadets.
- F. The Academy cancelled the 2022 Fox Trot (Part-Time) class which was scheduled to start on October 10, 2022)
- G. Vacancy available - There is a vacancy for an Instructor/Facilitator position to fill Ms. Heather Albano.

H. TCOLE has recently taken over TCLEDDS, making it more accessible by enabling to use and gather information more directly and efficiently, rather than using a third party as it was previously established.

6. New Business

A. Due too many new and price increases in the past year the Academy has struggle to stay within budget. At the request of the AACOG executive personnel and the Academy personnel I am requesting that an increase of \$300.00 be considered by the Advisory Board for the new tuition rate to be accepted for BPOC 2023-B. The new tuition rate would start with the BPOC 2023-B due to having already accepted approximately 20 applicants for the 2023-Alpha class and they were accepted into the class at the \$3500 tuition rate.
